Program Overview and Objectives

The 2023 Update will provide up-to-date information on prevention, management and treatment of sexually transmitted infections (STIs). This activity will address best practices as it relates to prevention strategies for STIs including congenital syphilis, HIV, viral hepatitis, *Chlamydia trachomatis* and *Mycoplasma genitalium*. Approaches to addressing risk factors for STIs during pregnancy, as well as management of substance use disorders during the peripartum period will be reviewed. Additionally, a framework for providing culturally competent STI care will be discussed.

Upon completion of this program, participants should be better able to:

- Examine the impact conscious and unconscious biases in health care have on people who are disproportionately affected by sexually transmitted infections (STIs).
- Identify risk factors for STIs during pregnancy and review the peripartum management of pregnant people with substance use disorders (SUDs).
- Identify risk factors for mother to child transmission of STIs and viral hepatitis and implement appropriate testing and treatment.
- Explain the findings from the Anchor Study and recommendations for anal cancer prevention.
- Describe the use of doxycycline PEP as an innovative public health strategy for STI prevention.
- Discuss *Chlamydia trachomatis* and *Mycoplasma genitalium* diagnosis and treatment updates.
- Review other general updates on STI diagnosis and management relevant to sexual health providers in NC.
