

The Clinical Teaching Associate Role

- The Clinical Teaching Associate (CTA) is an experienced professional nurse and clinical practitioner with an interest and commitment to teaching.
- The CTA demonstrates an enhancement of personal practice, a love of teaching and the desire to help promote the nursing profession as reasons for entering into this role.
- The CTA remains in employment of the health care agency while serving as clinical adjunct faculty for a school of nursing.
- The CTA enhances professional visibility and broadens the preceptor's scope of practice.
- The CTA serves as clinical adjunct faculty member responsible for a group of students in a clinical rotation for one assigned semester at a time.

Criteria Required to Become a Clinical Teaching Associate

- Completion of the CTA course is required to serve the health care agency and schools of nursing in this role.
- Completion of a formal preceptor course is recommended within one year from completion of CTA course.
- A Bachelor of Science in Nursing.
- One year of experience at Atrium Health Wake Forest Baptist or Novant Health.
- Two years of overall current clinical nursing experience and direct patient care.
- A commitment to classroom and clinical instruction.

Benefits

- Recognition as a clinical adjunct faculty at Winston-Salem State University or Forsyth Technical Community College.
- Participation in the School of Nursing's faculty meetings.
- Collaboration between education and practice.

Objectives

- Define the Clinical Teaching Associate (CTA) role including the specific responsibilities for Forsyth Technical Community College and Winston-Salem State University.
- Discuss the socialization of the registered nurse to the clinical teaching role.
- Discuss evidence-based practice as it relates to the clinical teaching environment.
- Differentiate the principles of adult learning theory including effective and ineffective feedback behaviors.
- Identify the legal aspects of clinical teaching including the NC Nurse Practice Act.
- Analyze assigned readings for integration into clinical practice.
- Analyze the clinical forms and student policies specific to Forsyth Tech and WSSU Schools of Nursing.
- Discuss the CTA clinical orientation requirements of Novant Health and Atrium Health Wake Forest Baptist.

45.0 Nursing Contact Hours
