Objectives

Upon completion of this program, participants will be able to:

- Identify risk factors for the development of neonatal hyperbilirubinemia.
- Identify signs and symptoms of hyperbilirubinemia and best practices for care.
- Discuss community resources available to children and families after discharge.
- Discuss information related to social and emotional supports offered to children and families enrolled in the North Carolina Infant-Toddler Program through the Winston-Salem Children's Developmental Services Agency.
- Identify potential routes from caregiving to trauma in an environment where infants and families with a substanceexposed pregnancy receive care.
- Recognize potentially traumatizing caregiving experiences.
- Identify opportunities to support colleagues when caring for infants and families with a substance-exposed pregnancy.
- Discuss high risk scenarios that may take place before and after discharge and identify factors that can determine outcomes.
- Examine the social worker's role and scope of practice related to infants and families experiencing an substance-exposed pregnancy.
- Relate nursing and social work practices to the overall care planning for infants and families experiencing an substanceexposed pregnancy.
- Relate the care team's assessments to potential custody outcomes.
- Describe potential safety plans when birth parents do not have full custody of children.
