Overview and Objectives

The 2024 Aging Well Conference is focused on healthy aging for the older adult. It is important for health professionals to meet the needs of our aging society. This activity focuses on advancing the knowledge and skills of healthcare providers in rural western North Carolina, particularly in geriatric care, addressing the unique healthcare needs of older adults. With a blend of individual and group presentations, panel discussions, and demonstrations, the activity brings together diverse perspectives of healthcare experts, researchers, government officials, social service providers, as well as older adults and family caregivers.

Fri., May 17th - Provider Conference: This day will be more focused for healthcare providers; community members are welcome.

Upon completion of this program, participants should be better able to:

- Apply integrative approaches to aging well, including physical activity, mental health support, and preventative health measures, to enhance the overall well-being.
- Identify effective resources and strategies for caregivers, emphasizing the importance of community and state-wide support systems in facilitating resilient caregiving environments.
- Describe current trends and innovations in managing aging-related health concerns, including cognitive impairments, hearing loss, and chronic disease management, with a focus on practical interventions and treatments.
- Apply knowledge and tools to protect the older adults from financial, physical, and emotional exploitation, highlighting legal resources, fraud prevention, and ethical considerations.
- Describe advanced care planning, legal considerations in guardianship and power of attorney, and the role of geriatric care management.
