# Understanding Different Motives of Domestic Violence Offenders and the Connection to Risk and

Lethality: A Trauma-Responsive Approach to Domestic Violence Intervention

## **Program Overview**

Day One: The River of Cruelty Model: A Trauma-Responsive Approach to Domestic Violence Intervention.

This presentation will introduce the foundational principles of the Family Peace
Initiative's trauma-responsive approach to domestic violence intervention. Participants will
examine how cruelty is passed from person to person and generation to generation, and how to intervene. Using an experiential approach, this workshop will explore the fundamentals of the
internal-focused dialogue, including working with feelings, connecting to the power of the "Golden Shadow Message"
and understanding the power of Alice Miller's "Enlightened Witness". Participants will learn practical skills that can be
applied immediately to their work with those who perpetrate domestic violence.

Day Two: Cracking the Code: Understanding Different Motives of Those Who Batter and the Connection to Risk and Lethality

This presentation "cracks the code" on battering behavior, bringing an understanding of the differences among those who batter based on motive to judges, attorneys, advocates, and other professionals working with domestic violence concerns. Those with different motives display different behaviors, and present different dangers to their victim and children. Through the use of videos and case examples, this information unlocks a deeper and more nuanced understanding of domestic violence. This workshop provides practical information that can improve safety considerations for victims and children, and intervention efforts with those who batter.

# **Faculty**

Dorthy Stucky Halley, LMSW, an international trainer, is co-founder and co-director of the Family Peace Initiative. She was the executive director of a domestic violence shelter from 1986 to 1996. She has worked with those who batter since 1991 and has served as an expert witness in domestic violence cases since 1989. She taught social work at Pittsburg State University for a decade before becoming the state's Victim Rights Coordinator and directing the Victim Services Division of the Kansas Attorney General's Office. Her development of a motivation typology for those who batter has opened the door to a more nuanced understanding for domestic violence professionals. She led the state efforts to develop standards and certify battering intervention programs. She has also served as President of: Kansas Coalition Against Sexual and Domestic Violence, Kansas Chapter of the National Association of Social Workers, and Kansas Organization for Victim Assistance. She currently serves on the International Public Policy Institute Board of Directors, and the National Battering Intervention & Prevention Network.

**Steven M. S. Halley, LSCSW**, an international trainer, is co-founder and co-director of the Family Peace Initiative, has been visionary in the development of a trauma-focused approach for intervening with those who batter. He is nationally recognized for his expertise in using a trauma-focused approach to intervene with those who batter, and in training others in this approach. His development of the "River of Cruelty" model that describes how cruelty is passed from person to person and generation to generation has been groundbreaking in the field. Along with his wife, Dorthy, he has authored curricula for working with those who batter, justice-involved women, and justice-involved youth. They have also authored The River of Cruelty, and Halley's Alley: Commentaries on marriage, family, healthy relationships, parenting, loss, grief, trauma, and domestic violence. Steve writes a monthly blog to assist professionals working with those who batter. It can be accessed through www.familypeaceinitiative.com. Steve currently serves on the National Battering Intervention Network.
