Program Overview and Objectives

Join us virtually on August 13th to explore the latest developments in sexually transmitted infection (STI) prevention, diagnosis and treatment specific to North Carolina. The 2025 Update will also address the multifaceted challenges posed by STIs, emphasizing



the importance of public health initiatives, comprehensive healthcare approaches, and the latest breakthroughs in research.

Upon completion of this program, participants should be better able to:

- Demonstrate the ability to obtain a comprehensive sexual health history using a structured framework and apply at least one shared decision-making model to patient scenarios in clinical practice.
- Analyze current STI trends among older adults and apply updated guidelines for screening and prevention in clinical practice.
- Explain the role of vaccines in STI prevention and implement current guidelines for administering STI-related vaccinations in clinical practice.
- Recognize common normal genital skin variants.
- Discuss point-of-care diagnostic tools to enhance the identification and management of STI syndemics in clinical practice.
- Outline the steps for implementing DoxyPEP in clinical settings and assess its effectiveness in STI prevention.
- Review other general updates on STI diagnosis and management relevant to sexual health providers in NC.
