Dr. Miller has published and presented research on counseling. In 2024, she published 2 books with Cognella (Academic Violence and Bullying of Faculty; A Practical Guide to Facilitating Substance Use Disorder Recovery). She has published a number of books with Wiley Press: Incorporating Spirituality in Counseling and Psychotherapy (2003), Fundamentals of Crisis Counseling (2011), Group Exercises for Addiction Counseling (2012), and Learning the Language of Addiction Counseling (5th Edition) (2021).

She is a member of the American Counseling Association's divisions of the Association for Spiritual, Ethical, and Religious Values in Counseling (ASERVIC) and the International Association of Addictions and Offender Counselors (IAAOC) and the American Psychological Association's Psychology of Religion (Division 36) and Addictions (Division 50). She has served on The North Carolina Addictions Specialist Professional Practice Board.
