Program Overview

Human service and community professionals often encounter clients/patients who present or have underlying Substance Use Disorders (SUDs). SUD professionals, who have worked in the field for decades, share their expertise, wisdom, and hope with professionals working with this population. This online 2-hour workshop consists of a moderator/panelist and 5 additional panelists.

The workshop is being presented in order to capture the history of the North Carolina SUD field from their diverse personal perspectives (e.g., gender; sexual orientation; race) and roles (e.g., administrator, supervisor, counselor, trainer). The last 45 minutes of the workshop will be a Q & A period.

This workshop will be beneficial to health and human service practitioners, including psychologists, social workers, counselors, marriage and family therapists, substance use and addictions professionals, clinicians and all others interested in this topic.

- Apply this information to their practice.

She currently has a book in press with Wiley, Inc [Group Exercises for Substance Use Disorders (2nd ed.)] and in 2024 published a book with Cognella, Inc [A Practical Guide to Facilitating Substance Use Disorder Recovery]. She has also published these books: "Academic Violence and Bullying of Faculty" (2024) (Cognella, Inc) and 8 books with Wiley Press ["Incorporating Spirituality in Counseling and Psychotherapy" (2003), "Fundamentals of Crisis Counseling" (2011), "Group Exercises for Addiction Counseling" (2012), and "Learning the Language of Addiction Counseling (5th Edition)" (2021)]. She is a member of the American Counseling Association's divisions of the Association for Spiritual, Ethical, and Religious Values in Counseling (ASERVIC) and the International Association of Addictions and Offender Counselors (IAAOC). Dr. Miller has served on the North Carolina Addictions Specialist Professional Practice Board.
